vulnerable children, providing stable housing, comprehensive nutrition, and
educational support. Our mission centers on mentoring each child toward
self-sufficiency and responsible citizenship. Beyond direct care, the Foundation
fosters regional economic stability through community-based initiatives, including
beekeeping vocational training and entrepreneurial development. The reported travel
expenses represent the direct costs of sending volunteer and leadership groups to
Kenya to execute our humanitarian service initiatives. These trips are vital for
project implementation, local oversight, and ensuring the efficient delivery of aid
to the community. All travel is strictly dedicated to fulfilling the organization's
exempt purpose, and participants engage exclusively in service-related activities.

While our primary focus remains in Kenya, we maintain a secondary program to provide
targeted emergency assistance, including healthcare access and trauma support, to
